NOTE: You will not receive a purse payment without a properly completed form on file. You must complete a new form if you wish to change your payment designation. (Purse-Payment Designation Form is attached.)

Your AMA Pro Racing License application must be approved before your entry will be accepted. AMA Pro reserves the right to determine inclusion or exclusion in any given class based on examination of a rider's performance and capability, as observed and documented through race performance, data and results. All information requested on the entry form must be provided in full and rider must have a current AMA Pro Racing license in order for the entry to be considered complete. Incomplete entries may be returned without processing. Entries must be RECEIVED by AMA Pro Racing no later than the established Entry Due Date for each event.

ENTRY CANCELLATION: When an Entrant submits an Official Entry Form and the entry is accepted, the Entrant becomes obligated to attempt in good faith to compete in the event to the best of his or her ability. If **written notice of withdrawal** from any scheduled event is received by AMA Pro Racing registration or the home office **prior to the first official practice for the referenced event**, the entry fee will be refunded **minus an administrative processing fee of \$25.00** for AFT TWINS Class Entries. For example, if you have entered five events and submit a written cancellation for four events prior to the first official practice session for the first scheduled event you are cancelling, there will only be one administrative processing fee incurred as the refund for all four cancelled events will be processed at one time. However, if each event is cancelled on an individual event by event basis, an administrative fee will be incurred each time that a refund is processed. Failure to make such written notice of cancellation prior to the first official practice for the referenced event, will result in forfeiture of the entire entry fee for the referenced event(s). If an event is cancelled due to inclement weather, refunds will be issued as outlined in Sec. 1.6 j in the 2018 Rulebook. **There is no provision for transfers or credits.**

VERIFICATION OF ACCEPTANCE: You can verify if your entry has been accepted for an event by visiting our website at AMAProRacing.com and locating your name on the entry list for that event. The entry list for each event is updated daily. Information specific to each event such as event schedules, purse information and supplemental regulations will be posted on our website as they become available.
