**Eligible Years:
2017-Current**

Branding Requirements:

- To be eligible for contingency payouts, riders must run an Indian FTR750 at all races in which their team participates for the 2019 season.
- Indian Motorcycle red, white and black and full "Indian Scout" logo need to be maintained on both tank panels. Additional tank logos must be approved by Indian Motorcycle prior to race.
- Indian Motorcycle patches are required on the upper chest (either side) and both shoulders of leathers. Patches available from Indian Motorcycle Racing.

How to Register:

- Competitors must submit photo of required leathers and tank panel one week prior to first race to racing@indianmotorcycle.com.

Branding Requirements:

- Kawasaki Lime Green **must** be the dominant color
- Kawasaki logos **must** (black or white only) be on both sides of the motorcycle.
- Kawasaki **must** be on the chest portion of leathers. Patches can be purchased or requested from Team Green at <https://www.kawasaki.com/>.

How to Register:

- Prior to enrolling, participants must contact Team Green at 949-716-0351 for additional information about how to enroll.

- Contact Team Green Racer Rewards to verify engine number and submit a photo of the race bike at teamgreen.contingency@kmc-usa.com.
- In addition to registration, riders must submit a signed [W-9 form](#) to teamgreen.contingency@kmc-usa.com.
- Following registration, riders will receive the Kawasaki Contingency Rewards MasterCard® (debit card) and automatic payments will be deposited directly to your card after Kawasaki receives "official" race results.
- No payments will be issued after January 15, 2020 for the 2019 Kawasaki Flat Track Racer Rewards Program. Please report any missed payments or errors within 30 days.
- **Competitors MUST enroll and verify registered VIN for qualifying vehicles.**

- KTM logo and plastics **must** be displayed.
- Motorcycle must contain genuine KTM VIN

- The Suzuki logo and plastic components must be displayed on the motorcycle for contingency eligibility

Branding Requirements:

- The "Yamaha" and "bLU cRU" logos **must** be displayed on the left and right side of all motorcycles.
- The "Yamaha" logo **must** be displayed on the chest of the rider's leathers and "bLU cRU" logo **must** be displayed on the rider's right shoulder to be eligible.

How to Register:

- Contingency will be paid to the Warranty Registered owner. If warranty registered owner will not be competing, but sponsoring a rider, contingency will be paid to the rider.
 - Riders must submit a 2019 AFT Twins/Production Twins Contingency Registration form by November 30, 2019 to be eligible.
 - In addition to registration, riders must submit a signed [W-9 form](#).
 - Following registration bLU cRU winners will be paid by check after Yamaha receives confirmation of results.
 - **Competitors MUST enroll and verify registered VIN for qualifying vehicles.**
